Please complete and return a copy of the following forms as soon as possible so we can schedule the services needed for you, your wedding attendants, and guests. Please be aware that our services often book months in advance, therefore it is best to reserve your appointment(s) as soon as possible.

Please be aware that this agreement is a contract that requires a \$25 non refundable fee and a credit card on file to reserve your appointments. To secure your appointment date, you must submit a signed contract and deposit. All wedding appointments are on a first come first serve basis. Without a signed contract and deposit, we will not reserve your date.

For your convenience, we can travel to you the day of your wedding. A fixed travel fee of \$150 will apply to all travel weddings up to 25 miles. This fee will increase for anything over 25 miles or for large parties (needing over 4 stylists). In the event that our services are required outside of normal business hours, (before 8 a.m., Sundays or holidays) other fees (of \$_____) will apply, please discuss before booking. Please be on time for your appointments the day of the wedding. In the event that any person is more than 20 minutes late, we may be unable to provide a full service, but full charges will still apply. Your total travel fee of \$_____ will apply for this appointment.

I, _____ agree to be responsible for all the members of my party. If any of the people for whom I have confirmed appointments should cancel without 60 day notice prior to the event, or fail to appear for their appointments, I understand that I will be charged for every confirmed appointment and service, including any appointments added on by phone, email, or verbally after the agreement is signed.
